Item No. 4: To report action taken by the Chairman

15.4.1 The Council while confirming the action taken by the Chairman noted that in the case of making officiating arrangement for the post of Director IIT Kanpur, the Chairman with the approval of the Visitor had appointed a person from outside the faculty of the Institute. The Council confirmed this action of the Chairman, and also authorised the Chairman to make such appointments in future from outside the faculty of any Institute in emergent cases.

15.4-2. It was reported that the Chairman of the Council had, in accordance with the authority given to him by the Council, and with the prior approval of the Visitor, appointed Dr. A.Bhattacharyya as Director, IIT Kanpur. The action of the Chairman of the Council was confirmed.

Item No. 5(i) To report analysis of admission and other particulars in IITs.

15.5.1 The Council noted the analysis of Joint Entrance Examination of 1975 made by Dr. A.K. Basu of IIT Delhi and expressed concern at the significant observation made therein that the rural non-SC/ST communities were grossly under-represented in the admission through the J.E.E. The Council therefore desired that this matter be studied in depth by a Committee which should take into account all relevant facts which may relate to medium of instructions, the standard of school education in rural areas, the environmental conditions etc.

15.4.2 The Council authorised the Chairman to appoint a Committee, in consultation with the Chairman of the U.G.C., to conduct an indepth study of the representation of students from rural areas, as well as from the weaker sections of the community especially the SC/ST in the IITs and other prestigious institution of higher lerning.

Itom No. 5(ii) To receive statistics of output of Ph.D. in Engineering and Beignee.

15.5.3 The Council noted the increasing trend towards giving more Ph. Ds, in Engineering in IITs and recorded the item.

Itom No. 6: To receive a report of facilities provided to scheduled Coste/scheduled Tribes condidates at the IITs.

15.6.1 The Council noted the efforts made by the IIIs to make ase of the quota reserved for admission to SC/ST students and was satisfied with the arrangements made.

15.6.2 The Council recommended that in order to help these students to take the Joint Entrance Examination confidently, Ministry of Home Affairs may be requested to set up adequate number of coaching centres as early as possible.

Item No. 7: To receive a report regarding Examination and Evaluation Technique at IITs.

15.7.1 The members felt that a uniform grading system in the IITs will be desirable and that this would be the first step towards achieving such a uniformity in the whole educational system.

15.7.2 The Council resolved that a workshop be organised wherein teachers from IITs as well as from U.G.C. should discuss and evolve recommendations for a uniform grading system as far as possible.

Item No. 8: To receive reports from IITs reserding dialogue with Industry.

15.8.1 The Council discussed the question of consultancy service at IITs at length and felt that in the formative stages of consultancy service, the rules should be flexible to help expand the activity. It was felt that consultancy services should be encouraged, so as to bring the Institutes closer to industry, to train the students to solve actual problems facing industry and to augment the resources of the Institutes to enable them to take up mission oriental research. At the same time care should be taken to see that the main functions for which the Institutes have been established, viz. teaching and research, do not suffer. The Council was of the view that income from consultancy services should not be

taken into account as revenue for purposes of calculating the grant, but such carnings should be used for developing the departments which would, in turn, improve the quality of consultancy service. However, in case of income from routine testings and for use of computers by outside agencies, the same may be treated as revenue.

15.8.2 The Council further desired that the Institutes should establish closer links with professional consulting engineers and also take steps to promote exchange of personnel between the industry and the IITs. The Council recommended that the students who have an aptitude and could be useful should also be involved in the consultancy work.

15.8.3. The Council resolved that the Institutes should frame proper guidelines for governing consultancy services of the IITs on the basis of above observations and submit the same to the Council for information.

15.8.4. The Council, felt that while preparing the budget of the Institute a comperchensive picture of the income from various sources including consultancy and expenditure on various heads should be given as vigualised in Section 22(1) of the IIT Act so that the Finance Committee and the Board of Governors get a clear picture of all the finances.

Item No. 9: To reconsider recommendations of the Council on reappointment of teaching staff on superanuation.

15.9.1 The Council was informed that in the last meeting it was decided that the teaching staff should retire at the

age of 60 years, and that no extension be granted beyond that.. However, in special circumstances with the approval of the Chairman of the Council, re-employment on contract basis may be given beyond 60 years.

15.9.2 The Council observed that under statute 15(1) there is already a provision for appointing eminent persons on contract. In view of this existing provision, Council decided that re-employment as visualised in the earlier decision be made, where necessary, in accordance with the existing statutes.

15.9.3 The Council further decided that as in the case of teaching staff, the retirement age in the case of Technical and Administrative staff will also be 60 years and that there shall be no extension of service beyond 60 years.

To consider the amendments to the Statutes as recommended by Haksar Committee.

15.10.1 The Council decided that the recommendations of Haksar Committee be first examined by the individual Board of Governors and their views be obtained latest by 12th May, 1976. The Council further decided to meet on 24.5.76 to consider the amendments to the Statutes.

Item No. 11:

To consider a mote on amendment of Statutes to provide for retirement after attaining 50 years of age or 25 years of service, (Director, IIT Kanpur)

15.11.1 The Council decided that individual Board of Governors of IITs should consider and formulate scheme for retiring those who had outlived their utility, and sond a detailed proposal to the Council by 31st October, 1976.

Item No. 12: To consider the report of Nayudanna Committee on Centres of Advanced Studies in IITs.

15.12.1 The report of the Nayudarma Cormittee was laid on the Table at the time of the meeting. As members did not have sufficient time to go through such an important item before deciding this issue, the Council decided to consider this report at its meeting on 24th May, 1976.

Ttem No. 13: To consider a note on mid-term appraisal of IITs and to recommend the revised Vth Plan requirements of IITs.

15.13.1 The Council was informed that detailed proposals giving the requirements of IITs were reported to Planning Commission, and that the Chairman had discussions with Directors regarding mid-term appraisal of the Vth Plan of each IIT. A proposal on the basis of such appraisal was made available to the Council (Appendix I).

15.13.2 The Council approved this mid-term appraisal and strongly recommended to the Govt. of India that the Vth Plan allocation for IITs $n_{\rm CY}$ be raised to Rs.44.89 crores.

Item No. 14: To consider annual budget allocation for 1976-77 for each of the five Institutes.

15.14.1 The Council was informed that a sum of Rs.628 lakhs have been provided in the annual Plan for 1976-77 out of which a sum of Rs.150 lakhs is to be carmarked for the purpose of Cantres of alvanced Studies on the recommendation of Nayudanna Committee. Thus, a sum of Rs.478 lakhs are to be Contd...9/-

allocated to the IIIs for their normal development. The Council decided to allocate Rs. 478 lakhs as under:-

15.14.2 The Council desired that the Govt. of India be requested to increase the annual plan allocation of 1976-77 for IITs to enable them to take up newer areas of research and development work.

Item No. 15(i) To consider the application of the enhaced value of scholarships to students in

15.15.1 The Council considered the proposal of IITs in the light of prevailing rates of scholarships in Humanities awarded by U.G.C. and decided that students undergoing Ph.D. courses in Humanities after obtaining Master's degree be awarded scholarship of Rs.400 p.m. for the first two years and Rs.500 p.m. for the next two years subject to proper academic assessment. This period is extendable up to six months in special cases and the decision is applicable with effect from 1.7.1974.

Item No. 15(ii) Extending the duration of th.D. Scholarships to 52 years (IIT Kanpur)

The Council noted that under the U.G.C. scheme,

Ph.D. scholarships are tenable for a period of 4 years only,

extendable in special circumstance by six months. The Council

therefore, decided that Ph.D. scholarships in IITs should be

of only 4 years duration. The period may be extended in special

cases for a period not exceeding 6 months.

15.15.3 The Council decided that IIT Kanpur should re-structure its Ph.D. courses so that the student is able to complete the work leading to Ph.D. degree in four years.

Itom No. 16: To consider the suggestion from Dr. Rajat Kumar Chakraborti, Member of the Council, for visiting TITs periodically.

15.16.1 The Council noted that members of the Council are invited to the convocations held in each of the IITs.

In addition, IITs may invite the members to summer schools, short-term courses and seminars conducted in IITs to enable the members of the Council to familiarise with the work of IITs.

Itom No. 17: To consider the note of Shri Chandy on grant of housing loans to the staff of Indian Institute of Technology.

15.17.1 The Council discussed the need for providing housing loans to staff in IITs but in view of constrains of funds, postponed a final decision on this item.

Item No. 18.

To consider a proposal of the Director,
IIT Delhi to revive the cedre of Associate
Professors in IITs. (IIT Delhi Director)

The Council noted that in its earlier meeting, it was decided to abolish the cadre of Associate Professors.

15-18-2 The Council reiterated its earlier decision that no further recruitment to the cadre of Associate Professor be made in IITs.

Item No. 19: To consider the proposal of Director, IIT

Kharagpur to relax the minimum qualifications

prescribed for the post of Lecturer in

Architecture and Naval Architecture.

Graduate qualifications in the areas of Naval Architecture Regional and Country Planning and Architecture, the Council decided that in the case of Lecturers for Architecture, Regional & Country Planning and Naval Architecture, the qualifications prescribed be relaxed at the timeof appointment, on the condition that the incumbent after selection acquires the prescribed qualification within a period of 5 years failing which he will not be eligible to draw further increments.

Item No. 20: To consider the report of the Committee on the cadre of selection grade for btenographers.

requirements, the Council resolved that the Chairman may decide the issue on receipt of detailed proposals from IITs.

Item No. 21: To consider a proposal received from Board of Governors of IIT Kharagpur regarding the revision of pay scales of Deputy Director, Registrar.

15.21.1 The Council recognising the need to appoint Dy. Directors from among the faculty, recommended that the pay scale of Dy. Director be revised from Rs.1800-2000 to Professors scale of pay (Rs.1500-2500) plus an allowance of Rs.250 p.m. with effect from 1.1.1973.

15.21.2 The Council recommended that the question of scales of pay of Registrar be considered only after the decision on the pay scales of Registrar of Central Universities is declared by the Government.

Iten No. 22: To consider the following proposal received from Board of Governors, Indian Institute of Technology, Kharagpur

15.22.1 The item was withdrawn.

Itom No. 23:

To consider the proposal of IIT Delhi to create a cadre of (1) Chief Dosign Engineer/Principal Scientific Officer (2) Senior Dosign Engineer/Senior Scientific Officer Gr. I/Workshop Superintendent and (3) Senior Scientific Officer Gr. II/Design Engineer/Assistant Workshop Superintendent in the IITs.

15.23.1 The Council decided that the matter be considered by the Directors of IIT and a detailed proposal be put up to the Council.

Item No. 24: To receive a note on the promotional opportunities of certain non-teaching staff working in IITs.

15.24.1 The Council was informed that Directors of IITs are formulating a proposal for promotional apportunities. When the proposals are finalised, these may be considered by the respective Board of Governors of the IITs and their views be sent to Council's Sectt. The Council resolved that Chairman of the Council may take a decision on behalf of the Council.

15.24.2 The Council also decided that the Chairman should consitute inter-IIT Cadre Management Committee to examine the question of rationalisation of various grades and methods of recruitment in the IITs.

The meeting terminated with a vote of thanks to the Chair.
