Minutes of the 42nd meeting of the Council of IITs held under the Chairmanship of Shri Kapil Sibal, Hon'ble Minister for Human Resource Development on 21st January, 2011 at IIT, Delhi

The 42nd meeting of the Council of the Indian Institutes of Technology (IITs) was held under the chairmanship of Shri Kapil Sibal, Minister of Human Resource Development on 21st January, 2011 at IIT, Delhi. The Minister of State for HRD, Smt. D. Purandeswari, Chairmen of Board of Governors, Directors of all IITs, Secretary (Higher Education) alongwith other eminent persons were present. The list of participants is at **Annexure – A**.

Item No.42.1: To confirm the Minutes of the 41st meeting of the Council of IITs held on 10.09.2010 at IIT Delhi

The minutes of the 41st meeting of the Council of IITs held on 10.09.2010 were circulated to all the members of the Council. The minutes of the meeting were confirmed subject to amendment in Item No.41.11 wherein the percentage of foreign students to be admitted in Post Graduate Courses would be 25% instead of 20%.

Item No. 42.2: To Report Action Taken on the Minutes of the 41st Meeting of the Council of IITs held on 10.09.2010

The Council took cognizance of the action taken on the minutes of the 40th meeting of the Council.

As regards appointment of foreign faculty, the Council was informed that MHA had authorized Indian Missions to grant employment Visas upto \$ 25,000. The members of the Council, however, pointed out that US \$ 25000 for grant of employment visa was not sufficient for recruiting faculty for IITs. The Council decided that the matter would be taken up with the Ministry of Home Affairs for providing further exemption to faculty of IITs vis-a-vis the limit stipulated for an employment Visa in the MHA instructions.

It was noted that apart from IIT, Guwahati which proposes to focus on South East Asian (ASEAN) countries for setting up a Centre on strategic studies,

IIT, Madras has also proposed to set up a Centre for developing expertise on countries like China.

Item No. 42.3: To report changes in the Membership of the Council

The Council welcomed the new members and placed on record its appreciation for the service rendered by the outgoing members.

Item No.42.4: Report of Dr. Anil Kakodkar Committee to suggest a road map for the autonomy and future of the IITs

Dr. Anil Kakodkar, Chairman of the Committee to suggest a road map for autonomy and future of IITs, set up in the 40th meeting of the IIT Council, made a presentation on the broad recommendations of the Committees before the Council. There were several observations made by the members. However, since the final report was not yet submitted by the Committee it was decided that these suggestions could also be considered by the Committee and that a final presentation would be made to the Council in which the other members of the Committee would also be requested to participate.

Item No. 42.5: Report of Dr. T. Ramasami Committee to assess the examination and admission system in engineering programmes

Since Dr. T. Ramasami could not attend the meeting, the Council resolved to authorize the Chairman of the Council to nominate members from the Council before whom this presentation could be done & decision taken accordingly by the Chairman.

Item No.42.6: Report of Dr. T. Ramasami Committee on curriculum review/ upgradation and suggest a way to make it socially and economically relevant

Since Dr. T. Ramasami could not attend the meeting, the Council resolved to authorize the Chairman of the Council to nominate members from the Council before whom this presentation could be done & decision taken accordingly by the Chairman.

Item No. 42.7: Report of Prof. S.G. Dhande Committee on the uniform / homogeneous criteria for promoting student from one semester to next in the IITs

Prof. Sanjay Dhande made a presentation on "uniform criteria for promoting students from one semester to the next in the IITs." The Council noted the credit based practices being followed by different IITs for promotion of students from one semester to the next. In order to ensure certain common features, it was agreed that the academic bodies of IITs should consider acquisition of credits as a criteria for movement of students and grant of degrees. Welcoming the suggestions made by the Dhande Committee, the Council agreed to review and implement these measures in due course. The actionable points would be culled out and followed / implemented by the Committee of Directors.

[Action: Committee of IITs]

Item No. 42.8: Report of Prof. S. G. Dhande Committee on requirement of infrastructure for research

Prof. Sanjay Dhande presented the Reports on the "requirement of infrastructure for research". In order to improve the research performance of the IITs, the Council welcomed the suggestions made by the Dhande Committee. The Council agreed to review and implement these measures in due course. The actionable points would be culled out & followed / implemented by the Committee of Directors.

[Action: Committee of IITs]

Item No. 42.9: Report of Prof. Devang Khakhar on attracting grants from UNESCO, Foundations and other multi-lateral agencies such as the EU.

Prof. Devang Khakhar presented a brief on the manner in which IITs could attract grants from UNESCO, Foundation and other multi-national agencies such

as the EU. The suggestions welcomed by the Members of the Council. The Council was informed that the IITs were already availing such grants. The Council accepted the Report of Prof. Khakhar. The actionable points would be culled out & followed / implemented by the Committee of Directors.

[Action: IITs]

Item No. 42.10: Presentation on "an academic programme on Cyber Security in IITs"

A presentation was made by Shri Shashi Kant Sharma, Secretary, Department of Information Technology to the Council on adopting "cyber security as part of the curriculum by IITs". It was decided that a Committee under Dr.R. Chidambaram would be set up (other Members to be nominated by Dr. Chidambaram) to develop a road map and give a report in next three months. The Committee would involve educational institutions as well as Government Departments for this purpose.

Item No. 42.11: Nominees of the Council in the Board of Governors of IITs

The Council deliberated and approved the lists of eminent persons for selection of members by the Council forwarded by IIT Kanpur and IIT Roorkee. (Annexure-I)

tem No. 42.12: Proposed role / functions of Secretariat of IIT Council

The Council deliberated on the issue and decided to entrust the following functions to the Secretariat of the IIT Council to begin with:

(i) To provide all necessary secretarial support to IIT Council, make necessary arrangement for holding the meetings of Council and SCIC and prepare Agenda & Minutes of these meetings.

- (ii) To initiate & co-ordinate action arising out of the decisions of the Council.
- (iii) To create and maintain an Internet Portal carrying information of the IIT System and serve as a repository of information in respect of all IITs. The Secretariat will put up and keep updating this information on the website of the Council of IITs.
- (iv) To co-ordinate with Ministry of Human Resource Development in all IIT related matters.
- (v) Any other function that may be assigned to it by the IIT Council.

[Action: IIT, Delhi]

Item No. 42.13: Creation of an Open Access Institutional Repository for Publications of IITs

The Council deliberated on the proposal for creation of Open Access Institutional Repository for Publications of IITs and decided to prepare a framework for creating a cyber platform for uploading publications and other research work of the IITs. For this purpose the Committee of Directors would develop this in a project mode.

[Action: All IITs]

Item No. 42.14: Selection of Directors through open advertisement.

The Council deliberated on the issue and decided that the appointment of Directors should be through a process of open advertisement in the national newspapers, through the website of the Council, website of the Ministry and websites of Pan-IIT Alumni Associations, in addition to addressing letters to various eminent persons requesting them to suggest names. This would give wide publicity and result in a more effective response to the post of Director of IIT.

Item No. 42.15: Establishment of International Institute of Technology (IIT) in Mauritius

Government of Mauritius has requested for establishment of an Institute of Technology in Mauritius. Section 6(1)(I) of the Act empowers the Institute to cooperate with educational and other institutions in any part of the world having objects wholly or partly similar to those of the Institute by exchange of teachers and scholars and generally in such manners as may be conductive to their common objects. During the 41st meeting of the Council of IITs, it was decided to make amendment in the Institutes of Technology Act, 1961, to make provision for setting up of campuses and branches of IIT abroad and to undertake broad-based collaboration with Institutions across the world. After deliberations, the Council decided that in principle approval may be granted for setting up an institute in Mauritius with the help of the Indian Institutes of Technology.

[Action: MHRD]

Item No. 42.16: Creation of a pool of Visitor's nominees in the selection Committees of Professors in IITs

The Council decided that a panel for Visitor's nominee for a particular department would be created which all IITs could use for the selection of faculty. This will ensure timely selection of Professors. However, amendments in the Statutes of IITs would have to be made for which Visitor's approval will be sought after the proposal has been approved by the BoGs.

(Action: IITs, MHRD)

Item No. 42.17: Removal of hostel seat fee from the list of statutory fees

The Council, after deliberations, approved the proposal for removing the hostel seat fee from the list of statutory fees. Each BoG of each Institute be

will take decisions according to the specific situation of each Institute, and with due sensitivity to the needs of students from weaker sections of the society. This will require amendment in the Statutes of IITs for which Visitor's approval will be sought after the proposal has been approved by the Board of Governors.

(Action: IITs, MHRD)

Item No. 42.18: Grant of additional PhD Fellowships to the top one percentile of the GATE candidates

The Council decided that a provision may be made for PhD fellowships to the top 1 percentile of the GATE candidates in each discipline. Candidates would be free to join any recognized PhD programme and draw fellowship from MHRD by an Institutional reimbursement mechanism similar to CSIR fellowships. Operation of this could be either through strengthening the present office that administers CSIR fellowships in science streams or through a separate office managed by the IITs.

(Action: IITs,)

Item No. 42.19: Introduction of HAG Scale of Rs.67000-79000/- without any Grade Pay in place of AGP of Rs.12000/- p.m. in Centrally Funded Technical Institutions including IITs

The Council ratified issue of order No. 23-1/2008-TS.II dated 15.09.2010 by the Ministry of HRD for making provision of HAG Scale of Rs.67000-79000/-without any Grade Pay upto a maximum of 40% of the posts of Professors at a given point of time, after six years of regular service in AGP of Rs.10000/- p.m. subject to performance evaluation based on research publications, Ph.D supervision, teaching and consultancy services etc. in IITs.

Item No. 42.20: Modification in the contract of service of Directors of IIT Kanpur, IIT Delhi and IIT Madras

The Council ratified the revised contracts of service of appointment of Prof. S.G. Dhande, Director, IIT, Kanpur and Prof. Surendra Prasad. Director, IIT, Delhi and Prof. M.S. Ananth, Director, IIT, Madras.

Item No. 42.21: Modification in the contract of service of Director of IIT (Supplementary) Roorkee

The Council ratified the revised contract of service of appointment of Prof. S.C. Saxena, Director, IIT, Roorkee,

Item No. 42.22: Nominees of the Council in the Board of Governors of (Supplementary) IIT Kharagpur and IIT Delhi

The Council deliberated and approved the lists of eminent persons for selection of members by the Council forwarded by IIT Kharagpur and IIT Delhi. (Annexure-II)
