



With reference to the above subject, the point-wise information is furnished hereunder:

a) Whether Government propose to introduce the tenure track system for hiring and promotion of Assistant Professors in Indian Institutes of Technology (IITs) across the country:

Answer: This matter was discussed in IIT Council Meeting dated 27.09.2019 and it was decided that the matter should be taken up in the BOG Meeting of respective IITs for possible implementation at each of the IITs. The matter will be taken up for consideration in the ensuing BOG meeting of IIT Tirupati.

b) If so, the reasons therefor:

Answer: Merits of the proposal will be considered by the Board of Governors

c) The details of seed funding that would be provided to these Assistant Professors for research purposes, institute-wise:

Answer: IIT Tirupati provides seed funding upto Rs 25 lakhs, based on the research proposal submitted by the faculty member.

d) The details of the infrastructure of all the IITs, including electricity connection, internet connectivity, number of functional computers and number of fully functioning science labs with its capacity, institute-wise: and

Answer: IIT Tirupati has been operating from a Temporary campus which currently has laboratories for Computer Science, Physics, Chemistry and Electronics. In the Permanent Campus, laboratories are available for Civil Engineering, Mechanical Engineering, Electrical Engineering and the Workshop which are catering to both B.Tech & M.Tech programs. All the classes for both UG & PG Programs are offered from the Permanent Campus. Hostels for the current student strength are operational in Permanent Campus at Yerpedu.

The Construction of further academic & residential buildings will commence from January 2020. These buildings to be completed by 2021 will cater to classrooms, research facilities for 1500 students and office space for 100 faculty members. During 2022-24 the 2nd stage of construction will be taken up to build facilities to cater to the needs of a total of 250 faculty and 2500 students.

e) The rationale behind setting the upper age limit as 35 for an Assistant Professor?

Answer: IIT Tirupati has been advertising a desirable age limit of 38yrs for faculty position at Assistant Professor level with a provision to relax in case of exceptional candidates. By the time, a person acquires his Ph.D. and Post-doctoral experience, he is already 30 years old. Unless a faculty starts his/her career early by the age of 35 or 38 years, experience shows that it is difficult to reach his/her full potential.




