In this regard please find point-wise inputs in respect of IIT ISM, Dhanbad which is given below:

Q. (a) Whether only two Indian higher educational institutions were featured in the recently published QS World Ranking list of 200 higher educational institutions and if so, the details thereof;

Ans. IIT (ISM) Dhanabad has bagged the 25th rank with an overall score of 71.5 in the QS World University Rankings 2023 for the mineral and mining engineering discipline and is first in the country in this subject domain.

In the year 2022, The Institute bagged 26th rank in QS ranking with an overall score of 74.1 for the mineral and mining engineering discipline.

It is mainly due to the focus of the Department of Mining Engineering and the Institute on improving the quality and number of publications in internationally-acclaimed journals and taking up sponsored R&D projects which went a long way in generating new knowledge. The institute was also working towards developing technology-oriented cyber-physical systems for mining, through the Technology Innovation Hub in Mining and Mineral Exploration. The Institute has scored 73.2, 60.5, 82.9 and 77.5 in Academic Reputation, Employer Reputation, Citation per Paper and H-Index Citations respectively.

Mining Engineering Department is almost a century old department founded with the foundation of the Institute in 1926 and has been serving the mining and mineral industry in India and abroad for almost a century by providing qualified mining engineers and mine managers with high reputation, maintaining high level of modern and updated curriculum, maintaining sophisticated laboratories, expert faculty members with significant practical experience as well as research experience, which helped the Institute in maintaining high academic reputation. The Institute also has a very high Employer Reputation as most of the top executives in different mining companies, Government authorities, Research Organizations and Policy making bodies or committees of the Institute are the product of this Institute. The Institute is also maintaining academic and research collaborations with many international institutions and research organizations.

The Institute is carrying out a number of high value research projects, to solve industry problems, sponsored by mining companies or other Govt. Funding agencies and a large number of publications are coming out as a result of such research activities, which ultimately helps in maintaining higher Citation per papers and H-index Citations.

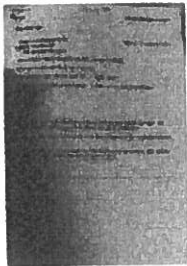

Main features of the app

- Her-Way provides a comprehensive solution to the problem of violence and harassment against women in public spaces.
- The app utilizes ML based algorithms to provide the **safest route** to travel for women. The factors taken into consideration are time of day, population density, crime rates in the area, distance from nearest police station.
- Trigger word detection which would trigger the SOS system alerting the emergency contacts and nearest police station.
- Emergency contacts, and a panic button that can be used in case of any danger or emergency.
- It also includes a fake call feature to evade a possible uncomfortable situation.
- A **community feature** where women can share their experiences, tips, and advise each other, providing a sense of safety and support. This will help-
 - The law enforcer to decide which areas to focus on(can include regular patrolling or setting up help desks).
 - Women to take appropriate precautionary measures.

Working process

Working of the ML Model:

The ML model analyzes the data obtained from various external sources to identify and suggest a safe route. Feedback from the community is analyzed using natural language processing techniques to infer the nature of the feedback, which is tagged with the location of the incident. Factors such as the location of various (insert word for safe and unsafe places), crime rate and population density are used to detect the proximity of these locations to different routes and evaluate the risk factor to suggest the safest route available.

ML-based Algorithms for Safe Route Selection:

The application leverages an ML model tailored to analyze multiple factors, thereby ascertaining the **most secure route** for women travelers. (For further elaboration, kindly refer to the "Role of AI" section).

When utilizing the app, users will input their desired destination and initiate a search for the optimal route. Subsequently, a seamless API call will be made to our server, procuring a vector of route points. These points will then be visually presented on the map, employing the MapBox SDK. Notably, the implementation of FastApi facilitated the seamless conversion of the Machine Learning model into a functional API.

Trigger Word Detection and SOS System:

Within the application, we have skillfully integrated **trigger word detection** technology through the utilization of PicoVoice's porcupine wake word detection library. Upon registration, users

have the opportunity to select specific trigger words that, when vocally expressed, signify potential danger or distress. When any of these predefined trigger words are spoken or shouted by the user, the SOS system promptly activates. Once activated, the SOS system effectively notifies the user's designated emergency contacts, which may include family members or friends. Additionally, it seamlessly initiates calls to emergency numbers via the Android call and messaging Intents, ensuring immediate assistance is at hand when needed most.

Fake Call Feature:

In order to provide users with a practical means to navigate potentially uncomfortable situations, our app incorporates a valuable fake call feature. This feature empowers users to simulate an incoming phone call, effectively creating a diversion that allows them to discreetly extricate themselves from uncomfortable or unsafe environments. The simulated call is crafted with a pre-set caller display and an authentic ringtone audio, ensuring it appears genuine and natural.

Community Feature:

Within the application, a noteworthy community feature has been incorporated, enabling women to engage in meaningful interactions by sharing their experiences, offering valuable tips, and providing advice to one another. This exceptional feature not only promotes a profound sense of safety but also fosters a strong support network among users, giving rise to a vibrant community capable of extending guidance and reassurance. Operating as a live feed based on the user's location, this dynamic platform allows individuals to freely communicate and exchange thoughts with fellow users. The open and interactive nature of this community strengthens the sense of solidarity among its members, creating an environment where women can freely express themselves, learn from one another, and foster lasting connections.

Role of AI

We utilize structured and organized data acquired by scraping the safecity.in website to train supervised Natural Language Processing (NLP) models. These models leverage textual incident descriptions to classify the severity scale and extract location details using Named Entity Recognition (NER) techniques.

The trained model enables the collection of valuable and well-organized data from unstructured sources like micro-blogging sites (e.g., Twitter) and other news forums. This crowd-sourced data includes location and severity tags for criminal incidents, and it becomes a dynamic factor in assessing the safety of a locality, complementing static factors such as population density, proximity to police stations etc.

The locality-wise safety index, derived from this tagged data is used as a parameter in route-planning algorithms to determine the safest possible routes. Additionally, we propose using various Machine Learning (ML) based forecasting techniques to track and identify patterns in the rise of criminal activity in different localities.

The ultimate goal is to empower individuals, communities, law enforcement, and city administration in creating safer public and private spaces, especially for women. By leveraging this comprehensive data-driven approach, we can enhance safety measures and foster a more secure environment for everyone.

Reply:

- (a) Yes, the reservation roster has been prepared after the implementation of CEI Act, 2019 w.e.f. 07.03.2019. The same has been approved by the BoG in its 27th meeting dated 04.08.2023 .
- (b) The following methods are has been adopted for preparing the preparing reservation roster for flexible cadre structure at IIT (ISM), Dhanbad:-
 - I. In all the recruitments made under Direct Recruitment on or after 07.03.2019, the reservation roster prescribed for Direct Recruitment on all India basis has been followed, which prescribed the following reservation: OBC - 27%; SC – 15%; ST – 7.5%, EWS – 10%.
 - II. The category of the internal faculty members shall remain unaltered, when they are promoted through selection the higher positions.
 - III. A sunset register having a list of the incumbents existing as on 06.03.2019, has been maintained along with the reservation category (if recruited under any reserved category).
 - IV. The year wise reservation registers w.e.f. 07.03.2019 for the posts of Assistant Professor/Associate Professor and Professor filled up through Direct Recruitment has been maintained. The backlog vacancies in a year are calculated in proportionate to the UR vacancies filled up in that year.
 - V. A single common 200-point roster for all the posts of Assistant Professor, Associate Professor & Professor filled up by the Direct Recruitment on or after 07.03.2019 has been maintained.
 - VI. Calendar year is the vacancy year. The roster is updated every year from January 2024 onwards based on the vacancy created in the last year.
