

This has reference to email dated 21.03.2020, information in respect of IIT (ISM), Dhanbad to Rajya Sabha Unstarred Question for answer on 26.03.2020 is furnished below:

(a) Total number of vacant faculty positions in Central universities, IITs, IIMs and NITs till date, category-wise for SCs/STs/OBCs and others;

Reply: In IIT(ISM) Dhanbad the total number of vacant faculty positions as on 23.03.2020 is 464.

(b) Total recruitment held for vacant positions during last five years till date, category-wise for SCs, STs, OBCs and others, university and institute-wise;

**Reply:** During last five years till date the total recruitment for vacant positions for SC, STs, OBCs is 05, 01 and 16 respectively.

(c) Reasons for high vacancy in posts reserved for SC, ST and OBC candidates as compared to positions for general category;

Reply: Not many vacancies in SC/ST/OBC categories when compared to total vacancies in faculty positions. Advertisement for teaching positions, in form of rolling advertisement of Faculty recruitment on the Institute's website, remain valid throughout the year and the Interviews are held periodically. But due to unavailability of suitable candidates, posts are remaining vacant in all categories. In this connection, it is to inform that the Institute follows the MHRD approved Four-tier flexible Cadre Structure ipso-facto in the recruitment of faculty which is mandated for IITs. As per existing criteria, the reservation in the Science & Technology Departments is applicable in the post of Assistant Professor only, whereas, in the Humanities & Social Sciences and Managements Studies, reservation is applicable at all levels.

(d) Steps taken by Government to fill vacant positions from reserved category; and

Reply: Not applicable

(e) Whether the IIMs/IITs are bound to follow reservation norms for SCs, STs and OBCs for all courses including fellowship programme?

Reply: IIT(ISM) Dhanbad follows the reservation norms of GoI.
