**Reply:** The Institute is making continuous effort to recruit deserving candidates through rolling advertisement, which is open throughout the year & offers reservation as per GoI norms. Also IIT Kanpur has been continuously giving thrust to recruit reserved category candidates through special recruitment drives as published vide Advt. Nos. DF4/2017 dated 20 July 2017 to 22 August 2017, DF3/2019 dated 14 August 2019 to 08 September 2019, DF1/2021 dated 26 August 2021 to 25 October 2021, DF-1/2022 Dated 22 November 2022 to 31 January 2023.

(b) whether the Government actively monitors the adherence of reservation norms by such institutes and if so, the details thereof;

**Reply:** The adherence of reservation norms is monitored by giving monthly update category wise recruitments on MoE portal for new faculty joining and also about remaining vacant positions. The progress of category wise recruitment is also reported to the Board of Governors in its every meeting.

(c) the specific steps taken by the Government to prevent caste discrimination against students belonging to Scheduled Caste (SC), Scheduled Tribe (ST) and Other Backward Class (OBC) communities in schools and colleges; and

**Reply:** IIT Kanpur has a SC/ST/OBC Cell. IIT Kanpur is committed to maintain a work environment wherein faculty, staff and student members from different communities can work in a coherent environment. It is the Institute's endeavour to ensure that no discrimination takes place. The Institute has appointed a Liaison Officer who can be contacted in the event of any incident of caste based discrimination.

(d) the details of trainings, if any, being imparted to school teachers and college professors on inclusive education and non-discriminatory practices?



Reply: IIT Kanpur has approved the recruitment of Professors of Practice at the Institute. The eligibility criteria for appointment as Professors of Practice at IIT Kanpur are:

Candidates should have reasonable (typically 10-15 years) managerial or professional experience and should have worked in a senior management position such as CEO/CTO/Vice President/Director for a reasonable period. PhD is desirable but not essential. However, lack of PhD must be offset by demonstrated domain knowledge, obtained from deep experience in the field of work.

(c) whether the dilution in educational qualifications required for Professors of Practice will affect the quality of higher education?

**Reply:** For appointment as Professor of Practice at IIT Kanpur, a master's degree is essential, while a PhD is desirable but not essential. However, a lack of PhD must be offset by demonstrated domain knowledge, obtained from deep experience in the field of work to ensure that the quality of higher education is not affected. The Professor of Practice is expected to enrich the experience of students by bringing deep understanding and appreciation of the best practices as applied in real world settings.
