

Progress Status of IIT Guwahati Research Park

The Ministry of Education (Department of Higher Education) sanctioned for establishment of a Research Park at IIT Guwahati on o3.10.2017. The Ministry had allocated ₹7500.00 lakhs for the construction of the Research Park at IITG. The Institute engaged architect M/s Wadia Techno Engineering Services Limited, Kolkata for architectural consultancy services of the building. After approval of conceptual drawings by the competent authority of the Institute, the building has been designed in two blocks, research block of G+9 storeys and office as G+7 storeys. The building has been planned with a total built up area of 21200.00 sqm.

Since the approved allocation of fund was not enough to complete all the amenities, it has been decided by the Institute that the extent of construction be restricted within ₹7500.00 lakhs with the following provisions:

The first phase of construction work has been started with a construction area of 19663.00 sqm and the following scope:

- 1. RCC superstructures of research block up to G+8 level and total superstructure of office block up to G+7 level.
- 2. Complete external finishes of both the blocks.
- 3. Complete internal finishing including electrical and HVAC of half part of research block up to G+6 level and ground floor of office block.

At present about 48% of the work has been completed. The RCC structural framework up to G+6 level has been completed. The work is progressing well and the structural work up to G+7 level is already completed. AAC block masonry work and internal finishing work up to G+2 level is in progress.

The Institute has received an amount of ₹4370.00 lakhs so far and the expenditure incurred so far is ₹3722.00 lakhs.

The scheduled date of completion of the work is December 2022. However due to the Covid pandemic and lock down condition since last year, progress of work could not be achieved as targeted. Effort is being made to complete at least two floors of the Research block ready by December 2021.



Notes for supplementary

As the building of the research park is under construction, temporary space has been provided by the institute to Research Park at the 2nd & 4th floor of the research building of IIT Guwahati to host the companies. Currently 14 companies have signed agreements with IIT Guwahati Research Park, namely, All Pro Auto Consultants Pvt Ltd, Bay Area Advanced Analytics India Pvt Ltd, RR Animal Health Care Pvt Ltd, Primary Healthtech Pvt Ltd, Olatus Systems Pvt Ltd, Stanvac Med Ltd, Bioaptagen Laboratories Pvt Ltd, Aquasolution, Ultimate Aeroaqua Filter Pvt Ltd, The Sustainable Environmental Resources Institute, Unised Research Consultants Pvt Ltd, Prism Johnson Limited, IIT Guwahati Technology Innovation and Development Foundation and Cygnusa Technologies Pvt Ltd. Discussions are on with few more clients who are expected to join the Research Park shortly. IIT Guwahati Technology Innovation and Development Foundation, a Section 8 company recently incorporated for the underwater exploration by the fund from DST has hired space in IIT Guwahati Research Park. One of the clients, RR Animal Healthcare Pvt Ltd, have developed and delivered large quantities of affordable covid 19 diagnostic kits which have been mentioned by Honorable Prime Minister, Sri Narendra Modi in Man Ki Baat on 22.08.2020 the link of which is https://twitter.com/mannkibaat/status/1297088964025651203.

A Logo Design Competition was organized by IIT Guwahati Research Park on 24th June 2019 inviting IITG fraternity to suggest a suitable Logo for IIT Guwahati Research Park. Along-with the design one had to specify what each color and design of the logo specify regarding the Research Park. The best logo would be selected as the Logo of IITG-Research Park. The result was declared on 13th Feb 2020 and Mr. Sanket Wakade was declared as the winner of the competition.

On 14th Feb 2020, Honorable HRD Minister Shri Ramesh Pokhriyal Nishank visited IIT Guwahati Research Park. The Minister released the new Logo for the Research Park and the winner of the Logo Competition was also awarded.

IIT Guwahati COVID-19 Grand Challenge was organized jointly by Indian Institute of Technology Guwahati and IIT Guwahati Research Park. The Covid 19 grand challenge was targeted at empowering students to conduct research to develop potential solutions to contain the spread of coronavirus. Top 20 ideas were shortlisted. Among them, the top 6 were awarded cash prize and a certificate and the next 14 were awarded certificate.

A National Online Seminar on Funding Opportunities for Innovation & Entrepreneurship was conducted by IIT Guwahati Research Park jointly with office of II&SI and Technology Incubation Centre of IIT Guwahati on 3rd March 2021 in order to provide an insight to different funding opportunities available at IIT Guwahati.



INTEGRATION 2021, an Industry-Academia Conclave aimed to provide ultimate platform for Industry Professionals and Academia to showcase their innovation and interact for excellent networking and reeducation opportunities is being organized by IIT Guwahati Research Park during the winter period of 2021 involving all the companies associated with Research Park. The convention is tailor- made to bring together the entrepreneurs, industry professionals, students and faculty under one roof to Meet, Interact, Connect, and Exchange ideas, knowledge and build new collaborations.

An online seminar was organized on 3rd March, 2021 (Wednesday) by the Office of Industrial Interaction and special Initiatives jointly with IIT Guwahati Research Park and Technology Incubation Centre, IIT Guwahati on Funding opportunities for Innovation and Entrepreneurship.

As a part of Azadi ka Amrit Mahotsav to commemorate the monumental occasion of 75th anniversary of Indian independence, a one-day online workshop on '3D Printing Techniques and their applications in Biomedical devices' was organized by IIT Guwahati research Park in association with North East Centre for Biological Sciences and Healthcare Engineering (NECBH), IIT Guwahati, Assam on 15.07.2021. The aim of this workshop was to provide an exposure and training to the researchers in NE region to the latest advances in 3D printing with a positive impact on the future research. In this workshop, different experts had shared their knowledge on techniques of 3D Printing its application in various fields of research focusing on Biomedical device development. Researchers, students, and faculties from all over the country including NE India participated and were benefited from the workshop. The participants rated the session as informative and excellent.

- i) Teaching materials, text books and references as well as journals are to be made available before embarking to teach in regional languages.
- ii) There is need of handholding students who have difficulty in learning in English. Standard text books need to be translated to regional languages as a first step.
- iii) All IITs need to make a coordinated effort to develop course materials in regional languages for benefit of students belonging to different regions.
- iv) To facilitate comfortable understanding of the main lectures by the students who studied in vernacular medium, supplementary lectures in different regional languages should be made available at Pan IIT level through projects like NPTEL.
- v) NPTEL/MOOC courses may also be developed in regional languages by willing faculty members at institute level.
