This has reference to your letter F.No.29-1/2016-TS.1 dated 27th March 2017 on the Empowerment of Women Committee.

- (i) The Institute has taken several steps to implement the provisions of sexual harassment of women at workplace (Prevention, Prohibition and Redressed) Act 2013 including appointment of Internal Complaint Committee (ICC). Faculty members are appointed as Faculty Advisors to promote a healthy working environment for all female students, staff and faculty. Students' Counsellor is also playing an important role in this regard.
- (ii) Other important measures taken in this regard are:

(a) Activities of Women's Grievance Redressal Committee (WGRC)

A committee comprising of faculty and staff members was constituted by IIT Bhubaneswar in order to promote a healthy working environment for all our female staff, students and faculty, to work towards building a gender-sensitized environment at our institute and to organize workshops and awareness programmes at regular intervals towards building a gender-neutral workplace. Student members are also being inducted to the committee to involve them in organizing workshops and training programmes.

The functions and duties of WGRC-IIT Bhubaneswar was publicized through posters in the academic, administrative and residential areas of IIT Bhubaneswar. Also, WGRC created a facebook page, WGRC-IIT Bhubaneswar, to reach every student of our campus and to give information of our upcoming events. Following are the events conducted recently by WGRC at IIT Bhubaneswar.

• Workshop: "Lightening a Lamp in You": WGRC, IIT Bhubaneswar conducted a workshop 'Lightening a Lamp in You' on 9th September 2016. Mrs. Bijayalaxmi Nanda, an eminent Academician, Activist, Writer all together took the workshop. In the inaugural function Dr. Remya Neelancherry, Chairperson WGRC welcomed one and all present there and invited Prof. R V Rajakumar, Director IIT Bhubaneswar to enlighten everyone. In his address the Director appreciated the effort of WGRC for conducting the workshop and empathized to the commitment of making IIT Bhubaneswar a gender-sensitized campus. After that our esteemed guest of honor Prof. Bijayalaxmi Nanda, Associate Professor, Department of

Mingle and revealed to be the confidence and a

Political Science, Delhi University, gave the inaugural address and highlighted the challenges that women face and gave a brief description about the whole day schedule of Workshop.

Session I: Women's Empowerment and legal awareness: conceptual and contextual analysis The lecture focused on the theoretical principles of feminism and the significance of legal rights for women's empowerment. It delved into the struggles of the women's movements in India to create laws for women here and its impact on gender justice in the country. She depicted feminist scholarship in India as a traction to examine the contextual aspects of laws leading to women's empowerment in the country. She also talked how honor killing is hampering the humanity and love.

Session II: Women and laws in India This session provided a brief overview of women specific legislation in India with their specific provisions. It focused on the PCPNDT Act, the Dowry Prohibition Act, The Protection of Women from Domestic Violence Act, the Protection of Women from Sexual Harassment Act and the Hindu Succession Act. At the end of workshop an interactive session was held in which students were INDIAN INSTITUTE OF TECHNOLOGY BHUBANESWAR WOMEN'S GRIEVANCE REDRESSAL COMMITTEE divided into three groups and given a task to present how would they contribute in building gender sensitivity in and around IIT Bhubaneswar. Groups came up with several initiatives and they gave the name of their initiatives as Prerna, Jyoti, Jagriti.

• Self-Defense Training Programme: A Self Defense program was conducted by WGRC-IIT Bhubaneswar, on 2nd, 9th and 16th October 2016. Instructor of the program was Mr. Rajesh Kumar Biswal who is a 2nd DAN black belt- 05250325 and a national referee of taekwondo federation of India. He is also general secretary of Taekwondo Association of Khurdha, Odisha which is affiliated to Taekwondo association of Odisha. This training programme mainly focused on protecting ourselves in different types of real time situations using various techniques in a three days course as follows:

Day 1: Introduction of trainer and his team to the student by chairperson WGRC. Subsequently, trainer Mr. Rajesh Kumar Biswal started the session with briefing history of taekwondo and its usefulness in different situations. Thereafter, he started teaching some basic exercise to increase body strength and also some of the techniques of self-defense.

The session was concluded after summarizing all the techniques and practice with different equipment.

 International Women's day celebration: WGRC, IIT Bhubaneswar organized a three day programme (4th, 5th and 8th March 2017) as a part of International women's day celebration-2017.

Day 1: Theme based completions on various events. Students from IIT Bhubaneswar and nearby educational institutions participated in various competitions. Shristy Jha, Sreeja Das, Mridul Rai, Sangeeta, Satya Samiran Nayak, Ganesh Niranjan Rao, Paritosh Pandey Sayani Bhattacharyya and Gauravi Kabaddi won the prizes in various competitions.

Day 2: Awareness programme on "Women rights as well as health & hygiene". The programme was graced by the presence of Chief guest Dr. Sruti Mohapatra, the Chairman of Swabhiman, a State Disability Information and Resource Centre, Bhubaneswar and Dr. Purarama Pradhan, Medical Officer, IIT Bhubaneswar. Dr. Sruti Mohapatra gave an inspiring lecture about the importance of the theme "be bold for change" stating her own experience. Dr Purarama Pradhan gave insight to human health, hygiene and safety during the awareness programme.

Day 3: International Women's Day Lecture & Cultural evening, The three day programme reached its culmination on 8th March 2017. Dr. Rajashree Bothale, Senior Scientist & Head of Water Resource Division, National Remote Sensing Centre, Hyderabad was the chief guest for the evening. The programme started with lighting the lamp followed by formal welcome address by the chairperson, WGRC. Honorable director Prof. R V Rajakumar gave the presidential address by sharing his thoughts and insights on the importance of such celebration. The chief guest of the day, Dr. Rajashree Bothale, gave women's day lecture on "Scientific expedition to Antarctica". The audience were fascinated by the unique and oncein-a- lifetime lecture experience. Thereafter, prizes were distributed to the winners in various competitions. The event was concluded by cultural programme with the performance from music society, dramatics society, and a narrative play by faculty members and their family. This events were sandwiched by some remarkable solo performances by the students. The program concluded with a token of appreciation given to the performers by honourable director Prof. R V Rajakumar, Chief guest Dr Rajashree Bothale and Dean R&D prof. R K Panda.
